Name of Project

Development of Parks and Garden / Development of Parks and Garden (Const. of Drainage System) / Development of Parks and Garden (Rehab/Impvt. Of Fence) which involves fire ball box, explosion jet and mist, backfilling works, glass window, speaker steel cover, centrifugal blower stand and supports, marginal buttress, reinforcing steel bar, structural concrete, excavation, reinforcing steel, structural concrete, removal of damage of grided fence, Concrete Masonry units, grille works and painting works.

1. The CITY GOVERNMENT OF ZAMBOANGA, through the **General Fund (AB FY-2011)** intends to apply the sum of **ONE MILLION TWO HUNDRED FORTY THOUSAND SIX HUNDRED EIGHTY FIVE PESOS (P1,240,685.00) ONLY** being the Approved Budget for the Contract (ABC) to payments under the contract for **Development of Parks and Garden / Development of Parks and Garden (Const. of Drainage System) / Development of Parks and Garden (Rehab/Impvt. Of Fence) (Cluster) (Zone IV, Zone IV and Zone IV)**.

Bidding will be conducted through negotiated procurement, per **Resolution No. AMP-12-0018 dated January 26, 2012** pursuant to Section 53.4 of the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
3. Pre-qualified Bidders must submit their Bids at the address below on or before **February 10, 2012** at 10:00 AM.
4. The required completion of the works is **Seventy Nine [79]** calendar days.
5. A. **Equipment to be used:** Welding Machine, Speed Cutter, Bagger Mixer, Concrete Vibrator, Bar Cutter, Oxy/Acetylene Outfit and Grinder
