INVITATION TO BID

Construction of Barangay Hall at Baluno

Name of Project

Construction of Barangay Hall which involves excavation, embankment, soil poisoning, reinforcing steel, masonry, carpentry, septic vault, plumbing, electrical, painting, cistern and water tank works.

1. The CITY GOVERNMENT OF ZAMBOANGA, through the General Fund (AB/SB #01 FY - 2011) intends to apply the sum of **FOUR MILLION TWO HUNDRED ONE THOUSAND PESOS (P4,201,000.00) ONLY** being the Approved Budget for the Contract (ABC) to payments under the contract for **Construction of Barangay Hall at Baluno**.
2. Bidding will be conducted through negotiated procurement, per **Resolution No. AMP-12-0024-11 dated February 03, 2012** pursuant to Section 53.1 of the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
3. The City Government of Zamboanga will hold a Pre-Bid Conference on **February 17, 2012** at 10:00 AM in the Office of the City Mayor Conference Room, City Hall, Zamboanga City, which shall be open to all interested parties.
4. Pre-qualified Bidders must submit their Bids at the address below on or before **March 06, 2012** at 10:00 AM.
5. The required completion of the works is **One Hundred Fifty [150]** calendar days.
6. A. **Equipment to be used:** Plate compactor, Bar & Tile cutter, Bagger mixer, Concrete vibrator, Porta lift, Acetylene/Oxygen outfit, Electric drill & planer, Welding machine and Angle grinder.
B. **Key Personnel:** Project Manager, Project Engineer, Material Testing Engineer, Pest Controller / Applicator and Foreman.
7. The City Government of Zamboanga reserves the right to accept or reject any Bids, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
