The method of payment will be Cash payable to the City Treasurer's Office. The Procuring Entity shall allow the bidder to present its proof of payment for the fees "machine copy of the official receipt" not later than the submission of their bids.
- 6. The City Government of Zamboanga will hold a Pre-Bid Conference on March 10, 2022 at 10:00AM at the Office of the City Mayor-Procurement, Acquisition and Award Division (PAAD) Conference Room, Villalobos Street, Zamboanga City, which shall be open to prospective hidders
