

INVITATION TO BID FOR

The CITY GOVERNMENT OF ZAMBOANGA, through the **General Fund** intends to apply the sum of **ONE MILLION SEVEN** HUNDRED SEVENTY ONE THOUSAND THREE HUNDRED NINETY TWO PESOS (P1,771,392.00) ONLY being the Approved Budget for the Contract (ABC) to payments under the contract for **Security Services** (PR No. Lot 1-100-23-01-0031; Lot 2-100-23-01-0028). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The CITY GOVERNMENT OF ZAMBOANGA now invites bids for the Lot 1-04 s.g. Security Services without NSP (Mon-Sun) and 02 s.g. Security Services with NSP (Mon-Sun); Lot 2-01 s.g. Security Services without NSP and 01 s.g. Security Services with NSP. Delivery of the GOODS is required by One (01) Year, Period of Contract Services is Three (03) Years. Bidders should have completed within a period of ten (10) years from the date of submission and receipt of bids, a contract similar to the Project, with a value of at least (50%) of the ABC and to meet other eligibility requirements stated in the Eligibility Documents. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184.

 Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.


