

INVITATION TO BID FOR

Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The CITY GOVERNMENT OF ZAMBOANGA now invites bids for the 03 s.g. Security Services W/OUT Night Shift Pay (NSP) and 03 s.g. Security Services with Night Shift Pay (NSP) Delivery of the GOODS is required by (184) Calendar Days, Period of Contract Services is Three (03) Years. Bidders should have completed within a period of ten (10) years from the date of submission and receipt of bids, a contract similar to the Project, with a value of at least (50%) of the ABC and to meet other eligibility requirements stated in the Eligibility Documents. The Procurement Project (referred to herein as "Project") is composed of **1 lot**, the details of which are described in Section VII (Technical Specifications).

2. Funding Information

- 2.1. The GOP through the source of funding as indicated below for **Supplemental Budget #01 FY** 2023 in the amount of SIX HUNDRED SIXTY NINE THOUSAND FOUR HUNDRED TWENTY PESOS ONLY (P669,420.00).
- 2.2. The source of funding is: LGUs, the Annual or Supplemental Budget, as approved by the Sanggunian.

3. Bidding Requirements

The Bidding for the Project shall be governed by all the provisions of RA No. 9184 and its 2016 revised IRR, including its Generic Procurement Manuals and associated policies, rules and regulations as the primary source thereof, while the herein clauses shall serve as the secondary source thereof.
